Parent DAILY Health Reminders Regarding Sending Students to School

To Our Egg Harbor Township School District Community,

This document contains the Egg Harbor Township School District's expectations regarding the safety protocols necessary for your children. Please read and review all information and conditions contained herein with the expectation that you will comply with all of the following conditions <u>EVERY</u> day your child attends school. You understand and agree that by sending your child to school, you are affirming that your child may attend school based on the conditions set forth in this memo, every day that you send your child to school.

REMINDERS

I understand that as a condition of sending my child to school, I will comply with the School District's health and safety protocols as listed below:

- I will assess my child/children's health in accordance with the below checklist **EACH** morning, **PRIOR** to school, to determine if my child is experiencing any of the symptoms listed below.
- I certify that my child has not tested positive for COVID-19 within the last <u>5</u> days, and is <u>NOT</u> currently awaiting the results of a COVID-19 test.
- I understand that any of the symptoms in the table below could indicate a COVID-19 infection in children, and may put my child at risk for spreading illness to others.
- I understand that this list does not include all possible symptoms, and children with COVID-19 may experience any, all, or none of these symptoms and,
- I understand that if I send my child to school with any of the symptoms listed in the table below, I will be called to immediately pick my child up from school,
- I understand that if my child is sent home from school based on Covid like symptoms, they should be seen by their primary care doctor/pediatrician or urgent care.
- I understand that if my child obtains a positive Covid-19 test result (not over the counter) that I will report this result to their school nurse (see below).
- I understand that if my child has a positive test result they are to remain absent from school to isolate for 5 days. Then on day 6 they may return to school but <u>MUST</u> wear a mask while in school and on the school bus during days 6 10.

• I will <u>KEEP MY CHILD HOME FROM SCHOOL IF THEY HAVE</u>: **(<u>ANY</u> TWO (2) OR MORE) SYMPTOMS from COLUMN A or (<u>ANY</u> ONE (1) OR MORE) SYMPTOMS from COLUMN B.)

Column A

Fever (measured or subjective) *
Chills
Rigors (shivers)
Myalgia (muscle aches)
Headache
Sore Throat
Nausea or Vomiting
Diarrhea
Fatigue
Congestion or Runny Nose

Column B

Cough
Shortness of breath
Difficulty breathing
New loss of smell
New loss of taste

- If **AT LEAST TWO fields in Column A are checked off** OR **ONE OR MORE of the fields in Column B are checked off**, I will keep my child home and contact my healthcare provider and/or my local health department for further guidance.
- I understand that my child's temperature must be below 100.4 degrees <u>WITHOUT</u> the use of medication or other intervention to lower it for at least 24 hours.
- I understand that by entering any Egg Harbor Township Board of Education building, I am re-affirming that I and/or my child have <u>NO</u> symptoms of COVID-19, and that I have complied with <u>ALL</u> of the above conditions.
- I understand that if <u>ANY</u> of the fields in Columns A and/or B are checked off, I will contact my child's school nurse (see below).
