



# Pandemic Response Team Meetings

#### **School-Based**:

Eight school-based pandemic team meetings comprised of school administration, school staff, parents and students (at the secondary level) Were held over two weeks in February.

#### Feedback/Themes:

- Models for more in-person learning
  - Alternating Cohorts: Group A in-person 5 days while Group B is virtual, then switch
  - Combine Cohort A/B (possible schedule changes; eating lunch in classrooms...)
  - AAABB & AABBB
  - 4 Days in-person, with 1 day virtual
    - Phase in elementary school, followed by the secondary level (i.e. screen time for elementary students)
  - o Identify and transition Rtl students (i.e. 504's, attendance issues, academic issues) to 5 day in-person instruction.
  - 5 Days in-person adhering to 6ft. Social distancing (this may include the use of physical barriers when social distancing in the classroom is not possible.



# Proposed Revisions to EHT RBS Plan to include Increased In-Person Learning

#### **Student Options:**

**In-Person Learning:** Student will attend in-person where adherence to 6 feet social distancing, to the greatest extent practicable, will occur. In areas where we cannot adhere, additional PPE will be provided. Students are **committed to attending school in-person**; will be marked absent when they do not. Virtual model can only be used for sickness and/ or quarantine. (Parent- School Communication is vital)

**Virtual Learning:** Student learning from home via Google Classroom and Google Meet for live teacher instruction. The Virtual learning option is being provided pursuant to <a href="Executive Order 175"><u>Executive Order 175</u></a>

- Virtual learning students will still have the ability to fully participate in live streamed teacher instruction, which
  includes: whole group instruction, mini-lessons, collaboration through breakout rooms, small group instruction and
  the completion of formative assessments and learning activities.
- This choice reflects <u>a commitment to virtual instruction</u> pursuant to Policy 1648.02, which will allow for one additional window to transition to in-person instruction at the <u>conclusion of the 3rd quarter in April. We</u> are building our plan regarding social distancing to the greatest extent practicable, other recommended mitigation strategies, and providing ppe, which are all affected by the number of students in any particular classroom, therefore we need precise numbers to plan.

# **Additional PPE and Mitigation**

PPE and physical barriers do not preclude one from Contact Tracing-

- Removal of unneeded furniture from classrooms
- Face shields for secondary (6-12) students
- Sanitizer
- Spray/paper towels and Wipes where needed
- Desks facing one direction
- Desk Shields for elementary (PK-5) students
